

PAYMENT POLICY

Publication Date: 29th June, 2026

Effective Date: 29th June, 2026 & 1st October, 2026 (see *notes below)

This Payment Policy and the schedule attached sets out Skyscanner's key expectations regarding pricing information partners provide to Skyscanner. It applies to all partners in all markets (including Direct Booking partners).

In this policy, "**We**", "**Us**", "**Our**" or "**Skyscanner**" means Skyscanner Limited and any group company of Skyscanner and "**You**" or "**Your**" means you, Our partner (whether online travel agent, carrier, hotel, car hire partner or other). "**User**" means a user of the Skyscanner platform who has access to Your goods or services via Our platform (whether or not the User ultimately transacts with You).

***29th June, 2026: The policy in Mexico has been updated to include Skyscanner's policy on TUA fees.**

***29th June, 2026: GCash is now an accepted majority payment option in the Philippines.**

***29th June, 2026: Wechat Pay is now an accepted majority payment option in the Chinese market, and the 'Other Payment Options' have been updated to include Kuaqian.**

***29th June, 2026: The 'Other Payment Options' have been updated in the Malaysia market to include alternative modes of payment i.e. e-wallet, MAYBANK2U, FPX, UP and UPI.**

***1st October, 2026: The policy in the Australian market has been updated. From 1st October, 2026 onwards payment fees will be banned in the AU market. See AU payment policy below.**

General

1. Pricing information provided to Us should be accurate and not misleading to Us or to Our Users.
2. Pricing methods and displays applied by You should at all times comply with all applicable laws and regulations, including without limitation the provisions introduced by the EU Second Payment Services Directive ("**PSD2**"), and in the UNITED KINGDOM The Consumer Rights (Payment Surcharges) Regulations 2012 (as amended by the Payment Services Regulations) ("**UK Payment Surcharges Regulations**"). It is Your responsibility to ensure that You are complying with all applicable laws, and this Payment Policy is intended to supplement (and not replace) Your obligation to ensure compliance.
3. The pricing information You provide to Us and then to Users prior to the point of check out must be clear and transparent and show a breakdown of the total price which includes all information You are required to show in compliance with applicable laws. Additionally, You shall comply with all other requirements We reasonably request from time to time as regards the price breakdown You present to Us or Our Users, including without limitation a breakdown of taxes which comprise the final price payable.

Majority Payment Option (MPO)

4. We display the price for inventory in the Majority Payment Option ("**MPO**") for that market (as specified in the schedule below) (the "**MPO Price**"). We do not (outside of our Direct Booking system) allow Users to specify the form of payment method they will use and rely on the MPO.
5. The MPO Price provided to Us must represent the genuine price payable by a User paying by that MPO, without the User having to satisfy other conditions or agree to any additional charges. It must include all ancillary costs necessary for the User to complete the booking (including resort fees, service fees, administrative fees or any other fee which is mandatory to complete the booking). Where these cannot be reasonably estimated or paid in advance, the fact that such costs will be payable must be (i) flagged prominently in Your terms and conditions; and (ii) notified to Skyscanner specifically in advance.

Instances for which this might be the case could include airport departure taxes that are only payable in cash at an airport or city fees which can only be paid at the end of a hotel stay.

6. Resort fees payable for hotel bookings should be clearly shown in the price provided to Us and to the User prior to the point of completing a booking.
7. In all cases, optional services which are not essential to complete a booking must be “opt in” only and not pre-selected.

Surcharges and Discounts

8. PSD2 bans the application of surcharges for the use of credit and debit card consumer payments within the EEA. This means that for all transactions between You (if You are based in the EEA) and an EEA User, there should not be a surcharge applied. In the UNITED KINGDOM, the UK Payment Surcharges Regulations bans the application of surcharges on ALL consumer payment methods (including all debit and credit cards, online payments and direct debits) if You are based in the UK and transacting with a UK User.
9. In all other cases (including corporate transactions), You should not apply a surcharge which is Excessive. “**Excessive**” here means a surcharge which is (i) more than 2% of the total basket value; or (ii) greater than the actual cost to take the payment, whichever is the lower of the two (unless stated otherwise in the schedule below). This means that if the cost of taking the payment is more than 2% of the basket value, You are still not permitted to apply a surcharge of more than 2%. For markets outside of the UK, EEA, Canada and the United States of America, in exceptional circumstances, based on prevailing market norms and only after thorough testing and explicit agreement in writing, Skyscanner may make exceptions to this clause 9 on a per market basis as stipulated in the schedule below.
10. We understand that You may wish to apply discounts to certain forms of payment. The use of discounts is not prohibited, but the application of such a discount within the EEA is regulated by PSD2 (and in the UNITED KINGDOM under the UK Payment Surcharges Regulations) and should not have the practical effect of operating as a surcharge on relevant payment methods. You are required to ensure any such discounts comply with all applicable laws and regulations.
11. Where a discount is available for the use of a particular payment method, that discounted price must only be shown to the User when the User has positively selected that form of payment and not before. The price shown to Us must be the maximum price that the consumer will pay by any payment method You accept for consumer cards. You may reduce the price by applying a discount when the consumer specifies the payment method they want to use at the point of check out, provided that the application of any discount is compliant with the terms of PSD2, the UK Payment Surcharges Regulations and any other applicable legislation.
12. Where a discount is available for using a particular method of payment (whether to an MPO Price or any other price), the way that the discount is shown in Your booking flow must be transparent and easy to understand by Users, such as (for illustration only) using a drop-down menu for different pricing options showing (- €x (VISA DEBIT) etc). It must be clear to Users how the total price has been calculated.
